1. What type of information do we collect about you?

We Arloesi Môn, will collect this type of information about you:

- Name
- Email Address
- Address
- Telephone Number
- Health Details

2. Why do we need your information?

We, Arloesi Môn collect your personal information so that we can

- Market our services

We will from time to time be anonymizing the information for the purpose of collecting statistics and research.

3. Legal Basis

We will always tell you the legal basis as part of a privacy notice on our forms at the point of collection.

4. Information Sharing

From time to time Arloesi Môn will share your information with partnering bodies and external organisations to collaborate on projects, host events and to answer the program's operating requirements. We will always tell you at the point of collection if we will be doing so and with whom. If we rely on your consent for processing, you have every right to object for us to share externally.
